

## ARCHIVED NLN POSITION STATEMENTS

In 2004, the NLN Board of Governors approved a policy that calls for all position statements issued by the organization to be reviewed every four years to determine their continued relevance. After each statement is reviewed by an advisory council, task group or special committee, a recommendation is made to the board (a) reaffirm (b) revise to incorporate specified language, or (c) archive (when they are judged to be irrelevant or inappropriate in light of the NLN's current mission and goals).

The position statements listed below, each of which had been approved by the NLN Board of Governors in the year(s) indicated, have been archived and are no longer in circulation.
